13	WHEREAS, Article XVIII, Section 14 of the Colorado Constitution (Amendment
14	20, the "Medical Marijuana Amendment") allows the use, acquisition, possession, production, or
15	transportation of marijuana or related paraphernalia for medical use by patients and their primary
16	caregivers; and

18	WHEREAS, C.R.S. § 44-10-301 specifically authorizes municipalities to adopting
19	licensing procedures and requirements for medical marijuana licenses; and
20	
21	WHEREAS, on November 3, 2020, the register electors of the City of Littleton
22	voted to allow for retail marijuana sales; and
23	
24	WHEREAS, city council wishes to make further refinements to the business
25	licensing provisions related to medical and retail sales of marijuana to more closely aligned with
26	other jurisdictions that have approved sales;
27	
28	WHEREAS, the City of Littleton has a valid interest in regulating the licensing,
29	zoning, and other impacts of medical marijuana centers in a manner consist with the health, safety
30	and welfare of its citizens.

33	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
34	THE CITY OF LITTLETON, COLORADO, THAT:

36	Section 1: Littleton City Code Chapter 3, Business Regulations, Section 20,
37	Medical Marijuana Centers is hereby amended as follows:

39	3-20-18: HOURS OF OPERATION:
40	A medical marijuana center may open no earlier than EIGHT O'CLOCK (8:00) A.M. nine
41	o'clock (9:00) A.M. and shall close no later than <u>TWELVE O'CLOCK (12:00) A.M. ten o'clock</u>
42	(10:00) P.M. the same day. A medical marijuana center may be open seven (7) days a week.

44	3-20-25: PACKAGING AND LIMITATIONS ON QUANTITY DISPENSED:
45	A medical marijuana center may not dispense more than two (2) ounces of a usable form of
46	medical marijuana <u>UNLESS A PATIENT HAS A PHYSICIAN EXEMPTION AS SET FORTH</u>

IN C.R.S. §44-10-501 et. seq. and six (6) marijuana plants, three (3) or fewer of which may be mature flowering plants per patient, per day. All marijuana sold or otherwise distributed shall be in a sealed container. Such packaging shall have a label that indicates the quantity and advises the purchaser that the marijuana is intended for use solely by the patient, and that any resale or redistribution to any third person is a criminal violation.

## 3-20-35: LIMITATION ON NUMBER AND SIZE:

There shall be no more than four (4) centers licensed in the city. <u>CENTERS SHALL BE</u>
<u>LIMITED TO A FLOOR PLAN OF FOUR THOUSAND (4,000) SQUARE FEET. Centers shall</u>
<u>be limited to a floor plan of two thousand (2,000) square feet.</u>

Any licensee previously licensed as a medical marijuana dispensary shall be exempt from the distance limitations in subsection 3-20-17(A) of this chapter. Medical marijuana dispensary licenses issued prior to June 30, 2010, shall be reissued as medical marijuana center licenses upon a finding by the licensing authority of compliance with all the requirements of this section. Such finding of approval or denial shall be made within sixty (60) days of the effective date hereof.

**Section 2:** Littleton City Code Chapter 3, Business Regulations, Section 21, Retail Marijuana Establishments is hereby amended as follows:

## 3-21-19: HOURS OF OPERATION:

A retail marijuana store may open no earlier than <u>EIGHT O'CLOCK (8:00) A.M. nine o'clock (9:00) A.M.</u> and shall close no later than <u>TWELVE O'CLOCK (12:00) A.M. ten o'clock (10:00)</u> <u>P.M.</u> the same day. A retail marijuana store may be open seven (7) days a week.

## 3-21-35: LIMITATION ON SIZE:

Retail marijuana establishment shall be limited to a maximum floor plan of two thousand (2,000) square feetFOUR THOUSAND (4,000) SQUARE FEET.

**Section 3:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The city council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

**Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
