AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, APPROPRIATING FUNDS FOR THE 2024 ANNUAL BUDGET FOR ALL MUNICIPAL PURPOSES OF THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE, DOUGLAS, AND JEFFERSON, STATE OF COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2024 AND ENDING DECEMBER 31, 2024

WHEREAS, Ordinance No. 24, Series of 2023 established the annual appropriation for municipal purposes for the City of Littleton, Colorado;

WHEREAS, Ordinance No. 12, Series of 2023 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado;

WHEREAS, appropriations have theretofore been made for the expenditures of monies pursuant to said budget; and

WHEREAS, the necessity of receiving and expending additional monies from the general funds could not have been reasonably anticipated during the time of the adoption of the budget and appropriation of funds in accordance therewith.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1: The budget of the City of Littleton for the fiscal year beginning January 1, 2024, and ending December 31, 2024, is hereby amended by the following additions:

Section 2: The provisions of the annual appropriations Ordinance No. 24, Series 2023 The total budgeted expenditures for the City of Littleton, Colorado for the period of January 1, 2024, to December 31, 2024 shall be amended to \$158,540,224.

47 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
48 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
49 clauses of such ordinance nor revive any ordinance thereby.
