## 1 CITY OF LITTLETON, COLORADO 2 3 **ORDINANCE NO. 16** 4 5 **Series**, 2024 6 7 AN ORDINANCE OF THE CITY OF LITTLETON, 8 COLORADO, APPROPRIATING FUNDS FOR THE 2024 9 ANNUAL BUDGET FOR ALL MUNICIPAL PURPOSES OF 10 THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE, DOUGLAS, AND JEFFERSON, STATE OF COLORADO, 11 12 FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2024 13 **AND ENDING DECEMBER 31, 2024** 14 15 WHEREAS, Ordinance No. 24, Series of 2023 established the annual 16 appropriation for municipal purposes for the City of Littleton, Colorado; 17 18 WHEREAS, Ordinance No. 12, Series of 2023 amended the annual appropriation 19 for municipal purposes for the City of Littleton, Colorado; 20 21 WHEREAS, appropriations have theretofore been made for the expenditures of 22 monies pursuant to said budget; and 23 24 WHEREAS, the necessity of receiving and expending additional monies from the 25 general funds could not have been reasonably anticipated during the time of the adoption of the 26 budget and appropriation of funds in accordance therewith. 27 28 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF 29 THE CITY OF LITTLETON, COLORADO, THAT: 30 31 **Section 1:** The budget of the City of Littleton for the fiscal year beginning January 32 1, 2024, and ending December 31, 2024, is hereby amended by the following additions: 33

**Section 2:** The provisions of the annual appropriations Ordinance No. 24, Series 2023 The total budgeted expenditures for the City of Littleton, Colorado for the period of January 1, 2024, to December 31, 2024 shall be amended to \$158,540,224.
