8 COLORADO, AS GOVERNING BODY OF THE CITY OF
9 LITTLETON, COLORADO, SEWER UTILITY
10 ENTERPRISE, AMENDING THE 2024 SEWER UTILITY
11 UTILITY ENTERPRISE BUDGET

13 WHEREAS, the city council established the City of Littleton, Colorado Sewer
14 Utility Enterprise (the "Enterprise") by Ordinance No. 6, Series of 2004; and

16 WHEREAS, the city council, as the governing body of the Enterprise, has the
17 authority under said ordinance to establish the budget for the Enterprise; and

18
19 WHEREAS, Ordinance No. 26, Series of 2023 established the budgeted
20 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

22 WHEREAS, Ordinance No 6, Series of 2024 amended the established the budgeted
23 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

25 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
26 THE CITY OF LITTLETON, COLORADO, THAT:

28 Section 1: The budgeted expenditures for the City of Littleton, Colorado, Sewer
29 Utility Enterprise for the period of January 1, 2024 to December 31, 2024, are hereby amended by
30 the following addition:

FUND	EXPENDITURES
Sewer Utility Enterprise	\$900,000

33 Section 2: The total budgeted expenditures for the City of Littleton, Colorado,
34 Sewer Utility Enterprise for the period of January 1, 2024 to December 31, 2024 shall be amended
35 to \$28,569,032.

38 Section 3: Severability. If any part, section, subsection, sentence, clause or
39 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
40 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
41 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
42 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
43 phrases may be declared invalid.

45 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
46 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
47 clauses of such ordinance nor revive any ordinance thereby.

50 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
51 of the City of Littleton on the 16th day of July, 2024, passed on first reading by a vote of 7
52 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library,
53 the Municipal Courthouse and on the City of Littleton Website.

54 PUBLIC HEARING on the Ordinance to take place on the 6th day of August, 2024,
55 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the
56 hour of 6:30 p.m., or as soon thereafter as it may be heard.

58 PASSED on second and final reading, following public hearing, by a vote of ___ FOR and
59 ___ AGAINST on the 6th day of August, 2024 and ordered published by posting at Littleton Center,
60 Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
