**AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, AS GOVERNING BODY OF THE CITY OF LITTLETON, COLORADO, SEWER UTILITY ENTERPRISE, AMENDING THE 2024 SEWER UTILITY ENTERPRISE BUDGET**

**WHEREAS**, the city council established the City of Littleton, Colorado Sewer Utility Enterprise (the “Enterprise”) by Ordinance No. 6, Series of 2004;

**WHEREAS**, the city council, as the governing body of the Enterprise, has the authority under said ordinance to establish the budget for the Enterprise;

**WHEREAS**, Ordinance No. 26, Series of 2023 established the budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

**WHEREAS**, Ordinance No 6, Series of 2024 amended the established the budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:**

**Section 1:** The budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise for the period of January 1, 2024 to December 31, 2024, are hereby amended by the following addition:

<b>FUND</b>	<b>EXPENDITURES</b>
Sewer Utility Enterprise	\$900,000

**Section 2:** The total budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise for the period of January 1, 2024 to December 31, 2024 shall be amended to \$28,569,032.

**Section 3:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.
