1 CITY OF LITTLETON, COLORADO 2 3 **ORDINANCE NO. 17** 4 5 **Series**, 2024 6 7 AN ORDINANCE OF THE CITY OF LITTLETON, 8 COLORADO, AS GOVERNING BODY OF THE CITY OF 9 LITTLETON, COLORADO, **SEWER UTILITY** 10 ENTERPRISE, AMENDING THE 2024 SEWER UTLITY 11 UTILITY ENTERRISE BUDGET 12 13 WHEREAS, the city council established the City of Littleton, Colorado Sewer 14 Utility Enterprise (the "Enterprise") by Ordinance No. 6, Series of 2004; 15 16 WHEREAS, the city council, as the governing body of the Enterprise, has the 17 authority under said ordinance to establish the budget for the Enterprise; 18 19 WHEREAS, Ordinance No. 26, Series of 2023 established the budgeted 20 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and 21 22 WHEREAS, Ordinance No 6, Series of 2024 amended the established the budgeted 23 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise. 24 25 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF 26 THE CITY OF LITTLETON, COLORADO, THAT: 27 Section 1: The budgeted expenditures for the City of Littleton, Colorado, Sewer 28 29 Utility Enterprise for the period of January 1, 2024 to December 31, 2024, are hereby amended by 30 the following addition: 31 **FUND EXPENDITURES** Sewer Utility Enterprise \$900,000 32 33 34 Section 2: The total budgeted expenditures for the City of Littleton, Colorado, 35 Sewer Utility Enterprise for the period of January 1, 2024 to December 31, 2024 shall be amended 36 to \$28,569,032.

Section 3: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.
