17 WHEREAS, Ordinance No. 24, Series of 2023 established the annual appropriation  
18 for municipal purposes for the City of Littleton, Colorado; and

19  
20 WHEREAS, Ordinance No. 5, Series of 2024 amended the annual appropriation for  
21 municipal purposes for the City of Littleton, Colorado; and

22  
23 WHEREAS, Ordinance No. 16, Series of 2024 amended the annual appropriation for  
24 municipal purposes for the City of Littleton, Colorado; and

26 WHEREAS, the necessity of receiving and expending additional monies from the  
27 general funds could not have been reasonably anticipated during the time of the adoption of the  
28 budget and appropriation of funds in accordance therewith.

31 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
32 THE CITY OF LITTLETON, COLORADO, THAT:

34 Section 1: The budget of the City of Littleton for the fiscal year beginning January  
35 1, 2024, and ending December 31, 2024, is hereby amended by the following additions:

FUND	EXPENDITURES
Health Insurance Fund	\$850,000
Property & Liability	\$125,000
Total	\$975,000

38 Section 2: The provisions of the annual appropriations Ordinance No. 24, Series  
39 2023 are hereby amended with the total of all fund expenditures amended to \$159,515,224.

40  
41 Section 3: Severability. If any part, section, subsection, sentence, clause or  
42 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the

43 validity of the remaining sections of this ordinance. The City Council hereby declares that it would  
44 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase  
45 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or  
46 phrases may be declared invalid.

47  
48 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict  
49 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer  
50 clauses of such ordinance nor revive any ordinance thereby.

53 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council  
54 of the City of Littleton on the 17<sup>th</sup> day of December, 2024, passed on first reading by a vote of  
55 6 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis  
56 Library, the Municipal Courthouse and on the City of Littleton Website.

57 PUBLIC HEARING on the Ordinance to take place on the 7<sup>th</sup> day of January, 2025,  
58 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the  
59 hour of 6:30 p.m., or as soon thereafter as it may be heard.

61 PASSED on second and final reading, following public hearing, by a vote of \_\_\_\_
